On 20 December 2020, at around 5:15PM, I had just returned home and heard a commotion coming from the carpark. I looked out of my window and noticed 3 men gathered around my motorcycle (Yamaha YZF-R155), FBQ9031M.

I went down immediately to find out what was going on. When I arrived at the carpark, Zoohri, the owner of Honda ADV150 (license plate FA4045T) approached me and asked if the Yamaha YZF-R155 belongs to me. I replied that I am the owner and he explained that 3 motorcycles (including his and mine) were involved in a hit-and-run incident.

The culprit, driver of ComfortDelGro Taxi SHC7157A was also at the scene when I arrived. Zoohri was with his brother-in-law and they both explained to me what had happened. They both were at the carpark to look at Zoohri's new motorcycle when they noticed damage to the coverset. They subsequently noticed significant damage to my motorcycle which was parked to the left of Zoohri's motorcycle and also damage on the motorcycle to the left of mine, a Yamaha Aerox, license plate number FRO95017.

A resident who was staying on the 3rd floor looked down the balcony and told them that all 3 motorcycles were involved in a hit-and-run incident and furnished them with the license plate number of the culprit. Zoohri made a phone call to ComfortDelGro Taxi Company and enquired about the details of the driver of SHC7157A. Zoohri then obtained the culprit's mobile number from ComfortDelGro and called him. The culprit only agreed to return to the scene when Zoohri mentioned that he will be making a police report. The driver of ComfortDelGro taxi SHC7157A admitted to reversing into the Yamaha Aerox, FBQ9501Z which caused it to fall to its right, onto my motorcycle (Yamaha YZF-R155,

FBQ9031M), which in turn caused my motorcycle to fall to the right onto Zoohri's motorcycle (Honda ADV150, FA4045T). All three bikes were parked and were stationary. The impact caused a loud noise and the driver stopped and alighted his taxi. When he realised what he has done, he sought the help of 2 passers-by to lift and arrange the 3 fallen motorcycles back to the upright position. Once the motorcycles were lifted off the ground, he left the scene without assessing the damages he caused and without leaving any note or contact information. The culprit only returned when Zoohri called him and told him there were witnesses and a police report would be made

As the culprit was not remorseful and insisted he did not hit-and-run. Zoohri went to the nearby Kampong Kembangan Neighbourhood Police Post to seek help. SGT Danial who was on duty at that point in time came to the scene. We explained the situation to SGT Danial and he advised us to make an online Traffic Police report using SingPass as this was clearly a hit-and-run incident. SGT Danial also mentioned that it was not necessary for the victims of this incident to obtain the personal particulars of the culprit for the purpose of making the Traffic Police report as the taxi's license plate number would suffice. My motorcycle suffered damages to its mirrors, handlebar grips, clutch and brake levers, footpegs, multiple scratches to the fairings and windscreen. Any internal damaged caused by the impact will be assessed at a workshop.

This hit-and-run incident occurred at the carpark of Block 110-112 Lengkong Tiga, at the motorcycle lots right beneath Block 112 Lengkong Tiga.

This report is made to document the hit-and-run offence committed by the driver of ComfortDelGro Taxi SHC7157A.
