Hi Mr Justin,

We refer to the above matter and our tele-conversation last week.

As spoken, third party driver had reported that he was injured after the accident. Therefore, private settlement is not advisable for this matter and AIG will resolve the matter under your insurance policy.

We understand that you would like to know the repair on third party vehicle. We have tried to negotiate at best with third party repairer and the adjusted repair cost is \$1,317.32(before GST).

The breakdown of our propose settlement with third party is as follows: -

1. Cost of Repair (with GST)	\$ 1,409.53
2. Loss of Rental (5days x \$125.19)	\$ 625.95
3. Loss of Income (5days x\$50.00)	\$ 250.00
4. LTA/GIA Search fee	\$ 2.00
Total	<u>\$ 2,287.48</u>
