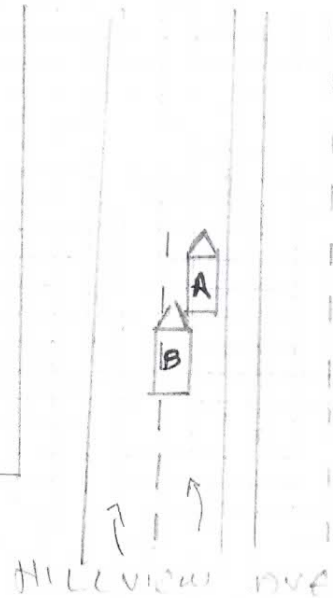

I felt unwell after the accident and will consult doctor later.

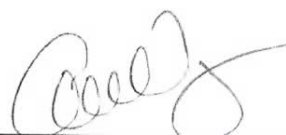
