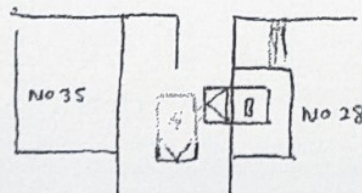
Sketch Plan

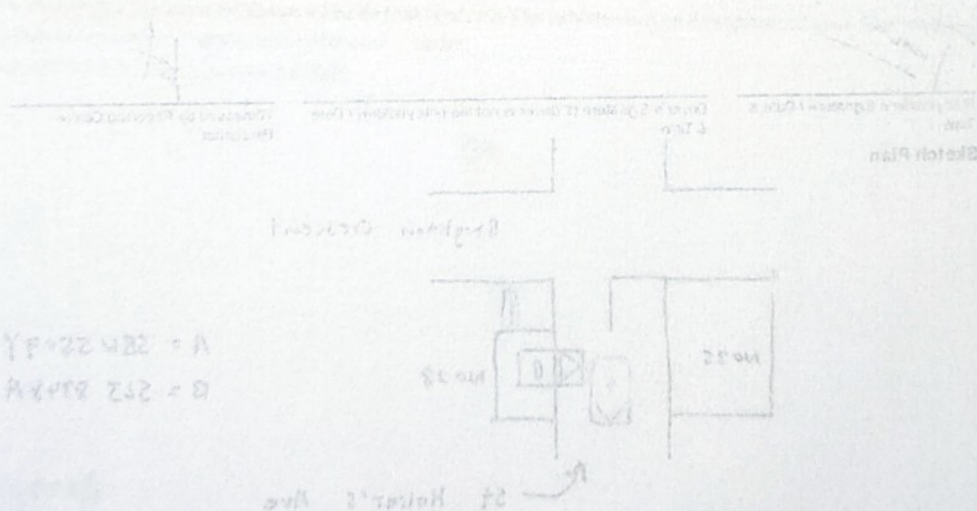
I stopped the car and horned. But there was no reaction from the driver. As there was no further reaction from the driver, I drove slowly past the car as it was blocking the road.
