

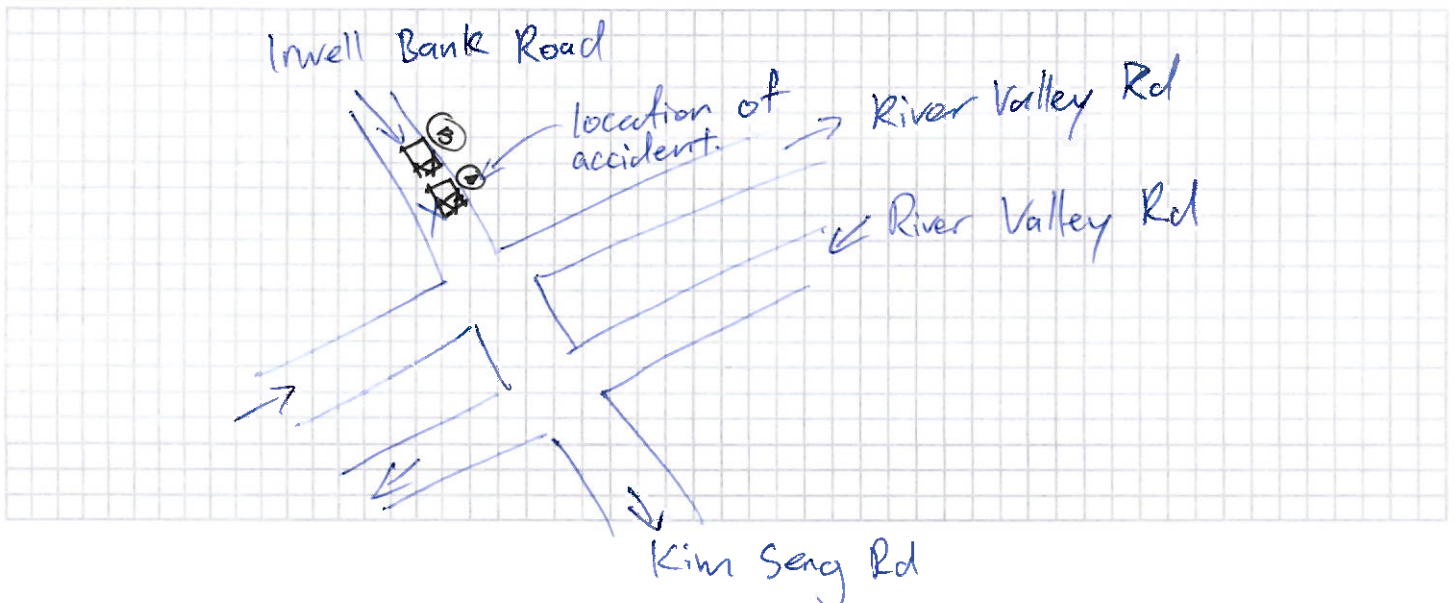

Describe Circumstances of the Accident


While driving towards Great World shopping centre, approaching the junction of Inwell Bank Rd / River Valley Rd / Kim Seng Rd, I was on the 2nd lane from the right, the vehicle in front of me made an emergency brake, the vehicle was a black Lexus (SKG 946D). I was able to stop in time and there was no contact with the black Lexus. However, after coming to a stop, I was hit in the back by a blue Comfort taxi (SHB 6232 C). There was enough distance between my car and the black Lexus, so no impact was made with the car in front. The black Lexus moved off and ~~was~~ did not stop to assist with the accident.

Before the accident happened, I noticed a black SUV on the extreme right lane, and the driver signalled right & was going to turn right, but just after the junction, the driver of the black SUV changed his signal & signalled left, he/she was on a turn right lane. There was a silver taxi in front of the black Lexus, the taxi jam brake due to the black SUV, this cause the black Lexus in front of me to jam on his brakes. As I had notice the black SUV trying to change lane, I had applied my brakes early, however I had to jam on my brakes when the black Lexus stop abruptly. This could be seen from the ~~on~~ board camera.


