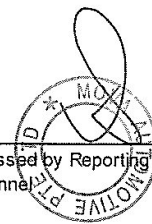

Sketch Plan

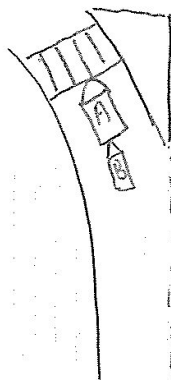
