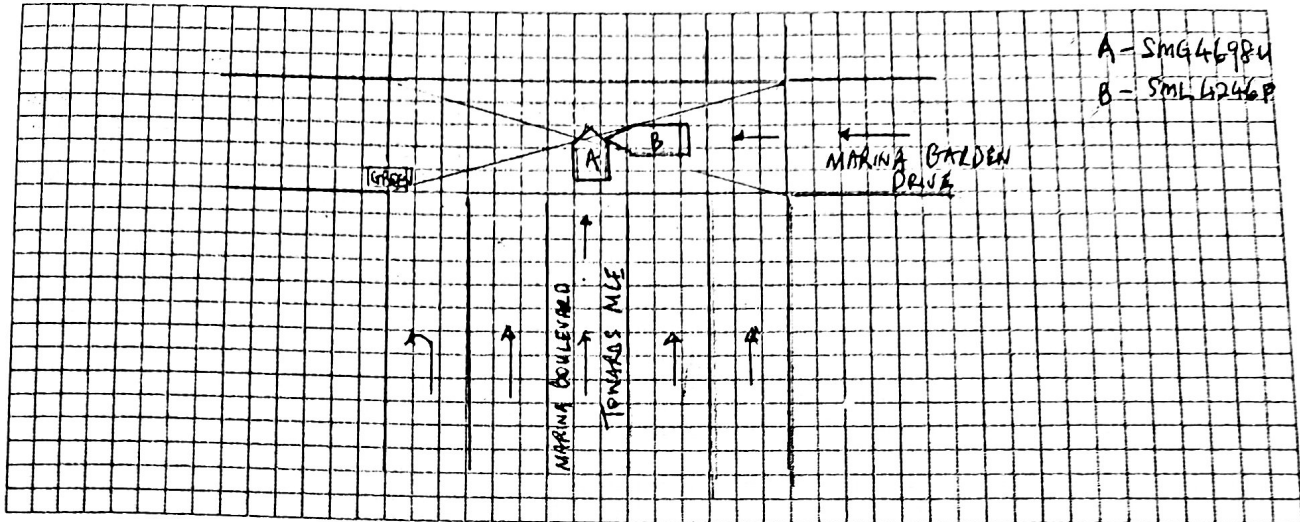

Brief Details.

On 6th Dec 2020, at around 4pm, I was driving along Marina Boulevard (third lane from the right) towards MCE, on the way sending my Grab passenger to Beach Station Sentosa.

The weather was clear. The traffic light was green in my favour while I was travelling towards the junction of Marina Boulevard and Marina Garden Drive. The car SML 4246P coming from Marina Garden Drive drove extremely fast; sped past the red light and collided into my car. My car was severely damaged. I overheard his passengers chided the driver for speeding past red light. I suffered neck, shoulder and lower back pains as a result of the impact of the accident. I consulted doctor on my medical condition and was given 3 days medical leave.

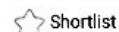
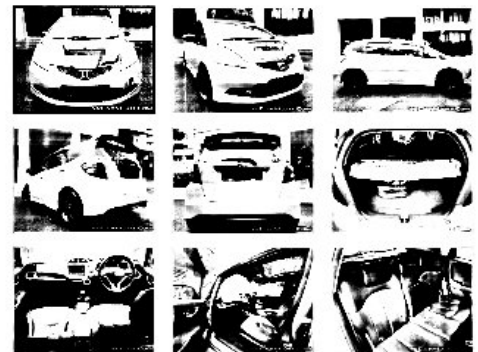

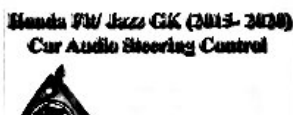
