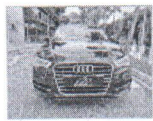

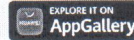



ACCIDENT REPORT

On the 2/1/21 rainy afternoon at about 2.35 pm I was driving the car (Audi A3 SKV 69588 "Car") along Stadium Boulevard roundabout heading towards the Singapore Sports Hub direction – planning to exit the roundabout at Stadium Drive.

As I approached the Stadium Drive exit at the roundabout, my Car was in lane 2 (middle lane). I signalled left and checked my blindspot to ensure that there were no oncoming vehicles and proceeded slowly to head towards the Stadium Drive roundabout exit, at a speed of about 30 km/hr.

Suddenly, a fast white SUV (Toyota SUV with plate SIV 1010F, Driver NRIC S8736217E YEO TING TING, JOLEEN) zoomed in from the rear left of my car and hit the front left passenger side my Car – the white Toyota SUV did not have its signal lights on. I jammed the brakes and stopped immediately, put on the blinking hazard lights at the roundabout and signalled Joleen Yeo to pull to the left coach stop/shelter of Stadium Drive as in the incident site was busy with cars. The white Toyota also pulled over and stopped in front of my Car. NO one was injured in both cars.

Driver Joleen Yeo was apologetic and repeatedly said that she "thought she could turn in that lane" into my lane, in other words continue straight in lane 3. She gave me her business name card and NRIC to take pictures and we then exchanged contact details.

The front left panels of my car (behind the front left wheel) were badly scratched with several patches showing the metal underneath the paintwork [see pictures taken at the site – both on site and after water was dried off].

The white Toyota SUV had paint scratch marks on the front right portion of the car, between the tire and the headlights [see pictures of white car scratch marks].

After exchanging contact details and taking photos of the damage on both cars, Joleen Yeo (Driver of White Toyota SUV) mentioned that she would inform her car insurer and we said that we would also likewise report the incident to our insurer to settle this matter.

As my wife and I had to prepare for our wedding banquet later in the evening, I did not check further if there was any other damage done to my Car and proceeded on my way at approximately 2.53pm.

The Car's registered owner Cheong Heng Lim (HP: 93397811) subsequently spoke to Mr Ah Heng (Audi 24-hr Audi Assist) at about 3:40 pm who told him to report matter on Monday (4 January 2021) at the Ubi Premium Automobile Service Centre.
