### Brief Details.

I am working under PNH Services PTE LTD as a Supervisor.

On the 19/11/2020 at about 1855 hrs, I was driving my vehicle (one Orange Toyota) bearing the registration no. GBJ9097K along Bukit Timah Expressway. At that point of time, the road surface was wet as the rain have just stopped. There were many vehicles on the road as well.

At about 1900 hrs, the vehicle (one silver Honda) bearing the registration no. SLH3075E, that was in front of mine, came to a stop. I was unable to break in time due to the road surface, which caused a collision to happen. The front of my vehicle knocked on to the rear of his vehicle. My vehicle is not damaged at all, however, the other party vehicle's bonnet is slightly dented. Nobody was injured when the incident took place. We then exchanged particulars.

No Traffic Police officers nor Ambulance attended to scene. I would like to state that I have lodged a Notice of Compliance on the 24/11/2020. However on the 16/12/2020, one Traffic Police officer messaged me via WhatsApp - 92783566 (HP) and asked me to lodge a police report under Traffic Police investigation Officer Christopher Ong, ref TP/IP/51667/2020.
