Describe Circumstances of the Accident.

On 09.01.2021, at about 2140hrs, I was driving my Comfort taxi, SHA7791D, on the right lane

along the entrance to the Vivo City taxi stand. The left lane is towards the carpark.

Traffic was quite heavy.

While queueing to the taxi stand, a private car, B, which was on the left lane came very close

to my taxi and then hit my taxi left front fender area.

I have a video recording of the accident impact. After the accident, B, went to pick up his

passengers and did not come out to talk to me. I stopped my taxi behind B and chased after B.

B did not bother to come out and just drove away.

No pax in my taxi and no injury.
