

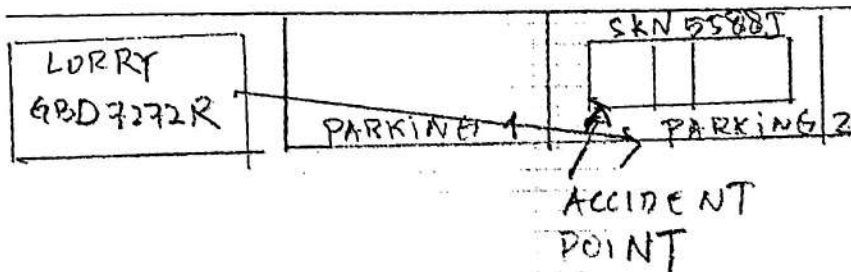


AT 12.30pm My team Reported that my car was hit on the front left side of the car. This is on Monday, 11 January 2021.


