CONTINUATION OF REPORT

Brief Details.

On 13/01/2021 at about 0720hrs, I was travelling in my blue Honda City car, JQJ5218 at the first lane of 4 lane road along KJE towards Tuas before PIE (Changi) exit. Subsequently, I slowed down and stopped due to heavy traffic. Upon seeing the second silver Toyota car, SJY1803T collided onto the first car, I applied emergency brake and managed to stop in time. Suddenly, I felt an impact from the rear portion and the force was so strong that my vehicle was pushed forward causing it to hit the first car. Subsequently, I stopped and alighted from the vehicle to inspect the damages and realized that it was a chain collision involving 6 cars. Due to the impact, I discovered that my front and rear portion was crumpled in. So far, no one was injured. My vehicle is not installed with any in-car camera and I do not have any witnesses. The 3rd vehicle which hit me from behind was a white BMW, SDW35G. After the accident, I felt some pain on the back of the neck and will be seeking medical treatment after lodging this police report.
