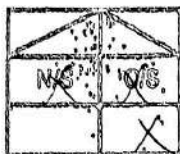

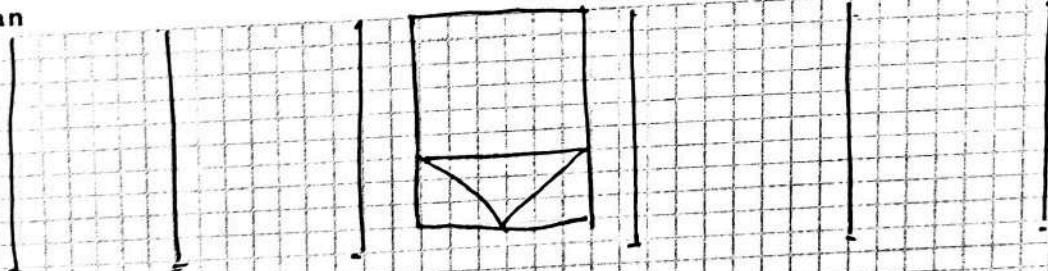

I am making this report to submit for insurance claims.

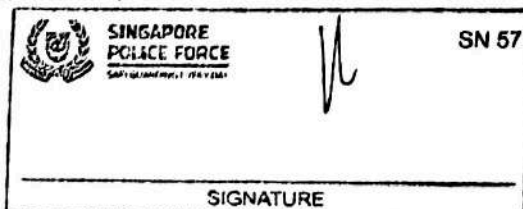
