Brief Details.

I am a grab driver driving vehicle number SLR5759A. I rented the car from Popular Rent A Car PTE LTD. On the 30/01/2020 I was informed by the rental company that they received a letter from Traffic police vide TP/IP/04313/2020 for an accident along South bridge road on the 05/01/2020 at 1835hrs. On that day, I was picking up a passenger from the Indian temple. I stopped behind a car in front of me to wait for my passenger. I then noticed that my passenger is in front, and as the car in front of me has his hazard light on, I tried to drive out to my left to overtake him. Before driving off, I checked my mirrors and saw no vehicle behind me. As I drove out, I heard a horn behind me. I checked my mirrors and saw a car behind me. However, our car did not make contact. After I moved forward towards my passenger, the driver drove and stopped beside me. I could see that he was shouting at me but I ignored him. He then drove off. I resumed with my work. No damages were seen on my vehicle. The driver also did not tell me to alight or inform me in any way that we were involved in an accident. That is all.
