5. My vehicle is repaired on my own will without any inducement, threat or promise.



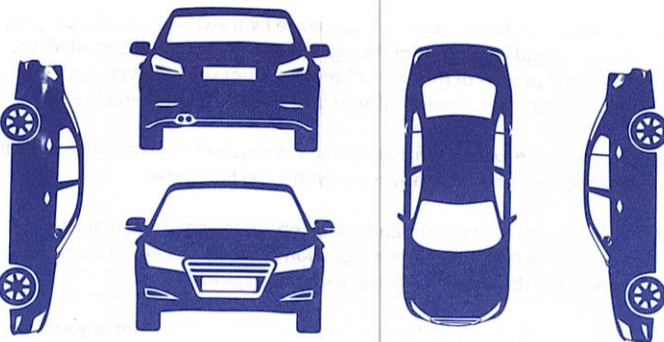
