

Dear All,

I Mr. Rahul Bhartiya holding Indian Passport No. Z4402150 was driving along Anderson Road, towards Orange Grove Road. The weather was wet with drizzle. I was driving at a snails speed (the same can be verified with the video shared) towards the T junction (Orange Grove Road) to turn right towards Shangrila Hotel. There was a bike in front of me at the T junction and I was stationery behind the biker. When the biker turned right I also moved ahead and I was the first at the T junction. There was no traffic coming from the right but there was a flow of traffic from my left.

When I found the right side absolutely clear I very slowly moved my car forward to position my car in the middle of the road to turn right as soon as the traffic from the left stopped.

I was stationery at this position for almost 12 seconds (the same can be verified with the video shared) when the traffic from the left reduced I inched forward with almost 0 speed when this bike came from my right and skid and fell in front of my car.

THERE WAS NO CONTACT WITH THE CAR AND THE BIKER OR THE BIKER.

I got of the car helped the biker with the assistance of other drivers to take the bike and the biker to the side of the road. The biker was able to walk with a kind of limp and then he said he is fine. I requested to call police or ambulance and he said that he was ok and there was no injury and no need to call anyone. Suddenly there were 4 to 5 people around us and trying to get involved in the matter and started asking me for my memory chip of the camera and assistance with insurance claim. Sensing something is wrong I kept my cool and did not hand them anything and instead I exchanged mobile nos, with the biker and we took pictures of each others driving license.

Upon reaching home I downloaded the video and on wats app I shared the video with the biker and asked him if he was reporting to the police as there was no contact no injury and no damage.

I got no response from him and thought that the matter is well rested.

To my surprise when I checked my office mail box yesterday I received letter on the incident from police from AIG and from a lawyer.
