- 9. The said vehicle shall be covered under a Vehicle Insurance Policy which contains an excess Clause as Stipulated/Stated inside the current Owner's Car Rental Folder. Driver needs to pay both excess 1 and 2 immediately after the accident occurred.
- 10. On prior to the expiration of the period of hire, the Hirer shall return the said vehicle together with all tyres, tools, accessories and equipment to the Owner's designated stations in as good order and condition as the said vehicle was when collected by the Hirer from the Owner.

- 21. Usage of the vehicle overseas is permitted only within Johor Bahru of Malaysia. Hirer will have to inform the company in the event that he/she wishes to travel to other parts of Malaysia
- 22. In the event of breakdown when the vehicle is overseas, Hirer will have to be liable for all fees and charges, which include towing and repair charges
