Brief Details.

On 19/01/2021 at about 1750hrs when I exited CTE (towards SLE) to Ang Mo Kio Avenue 3, I stopped at the traffic junction and when the lights were green, I moved forward but was caught in the middle of the junction as there was a congestion in front of me (Ang Mo Kio Avenue 3 towards Hougang Avenue 2). When I was inching forward as the traffic begins to flow, a vehicle bearing license plate no. SKU6099K whom was travelling along Ang Mo Kio Avenue 3 towards Hougang Avenue 2 drove into my way and his vehicle front right bumper came into contact with my front left bumper. Both our vehicle had minor scratches on our respective bumpers.

We immediately came down of our vehicle and he took my particulars. I asked him if he was okay and he said he and his passenger were fine and informed me that this is a small issue. He also informed he that his vehicle was a rental vehicle and he would proceed to the insurance company for a claim. I agreed to it and both of us drove off after.

On 21/01/2021, I received a phone call from my insurance company stating that there was a claim being made against me and also informed me that the other party took a 3 days MC due to injury from the accident on 19/01/2021.

I wish to state that during the time of the accident, the other party did inform me that he was not injured as well as his passenger on board.
