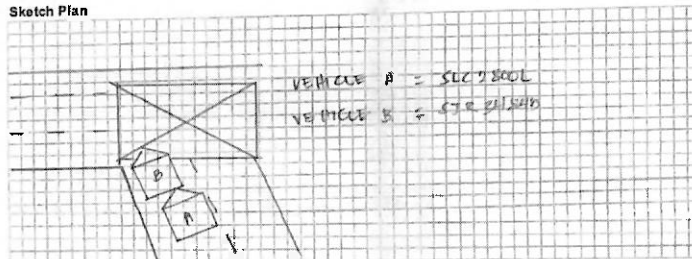

Sketch Plan


