



Brief Details.

On 12/12/2020 at about 1317hrs, while I was riding along AYE towards Tuas (near to NUH) on Lane 2, all of a sudden a taxi side mirror side swiped on my motorcycle's handle bar causing me to lose balance and rolled along the road surface area towards Lane 1. 
