#### CIRCUMSTANCES OF ACCIDENT

I WAS DRIVING ALONG AYE NEAR CLEMENTI EXIT TOWARDS JURONG WHEN SUDDENLY THE CAR IN FRONT OF ME JAMMED BRAKE (SLJ2352B). I IMMEDIATELY STEPPED ON THE BRAKE AND MANAGE TO STOP MY CAR ON TIME AND DID NOT HIT THE CAR IN FRONT. I HAD ABOUT HALF A METRE SPACING. WITHIN A SPLIT SECOND, I SAW IN MY BACK VIEW A SILVER CAB COMING TOWARDS MY CAR AND I FELT A CRASH ON MY BACK AND MY CAR SURGED FORWARDS AND HIT THE CAR IN FRONT. THE SILVER CAB (SHB8659S) WAS VERY FAST AND FAILED TO STOP IN TIME AND CRASH INTO MY BACK, THE IMPACT SENT MY CAR FORWARD AND BUMPED THE CAR IN FRONT OF MY CAR. ALL 3 DRIVERS CAME OUT AND ACKNOWLEDGED THAT THE SILVER CAB (SHB8659S) WAS THE PARTY AT FAULT FOR CRASHING INTO MY CAR, THEREFORE CAUSING MY CAR TO SUBSEQUENTLY HIT THE CAR IN FRONT OF ME (SLJ2352B). DRIVER OF (SLJ2352B) ALSO CONFIRM THAT MY CAR DID NOT HIT HERS UNTIL THE SILVER CAB CRASHED INTO ME AND SENT MY CAR FORWARD INTO HERS.

### Describe Circumstances of the Accident

I was driving along AYE near Clementi road exit towards Jurong when suddenly the car in front of me jammed break (SLJ 2352B). I immediately stepped on the break and managed to stop my car in time and did not hit the car in front. I had about half a metre spacing. Within a split second, I saw in my back view mirror a silver cab coming towards my car and I felt a ~~surge~~ crash on my back and my car surged forward and hit the car in front. The ~~impact~~ silver cab (SHB 8659S) was very fast and failed to stop in time and crashed into my back, ~~thereby~~ the impact sent my car forward and bumped the car in front of my car.


All 3 drivers came out and acknowledged that the silver cab (SHB 8659S) was the party at fault for crashing into my car, therefore causing my car to subsequently hit the car in front of me (SLJ 2352B). Driver of (SLJ 2352B) also confirm that ~~before~~ my car did not hit hers until the silver cab crashed into me and sent my car forward into hers.
