Describe Circumstances of the Accident

On 21 January 2021 at 6:01pm I was driving Veh A (SL2298P) along Woodlands Avenue 12 towards SLE. The traffic in front suddenly slowed and I followed suit and stopped my vehicle. Suddenly I felt a big bump from my rear. The force of the impact was so big my car lunged forward and hit the vehicle in front. I was hit by vehicle B (GW8080L). Due to the rain and confusion of the accident, the ~~veh~~ driver of Veh C only came down his vehicle, took a look and drove off, I was unable to note down vehicle C, particulars and vehicle number plate.

After the accident I wasn't feeling well and visited W Medical Pte Ltd and was given 3 days MC (0000002842)
