

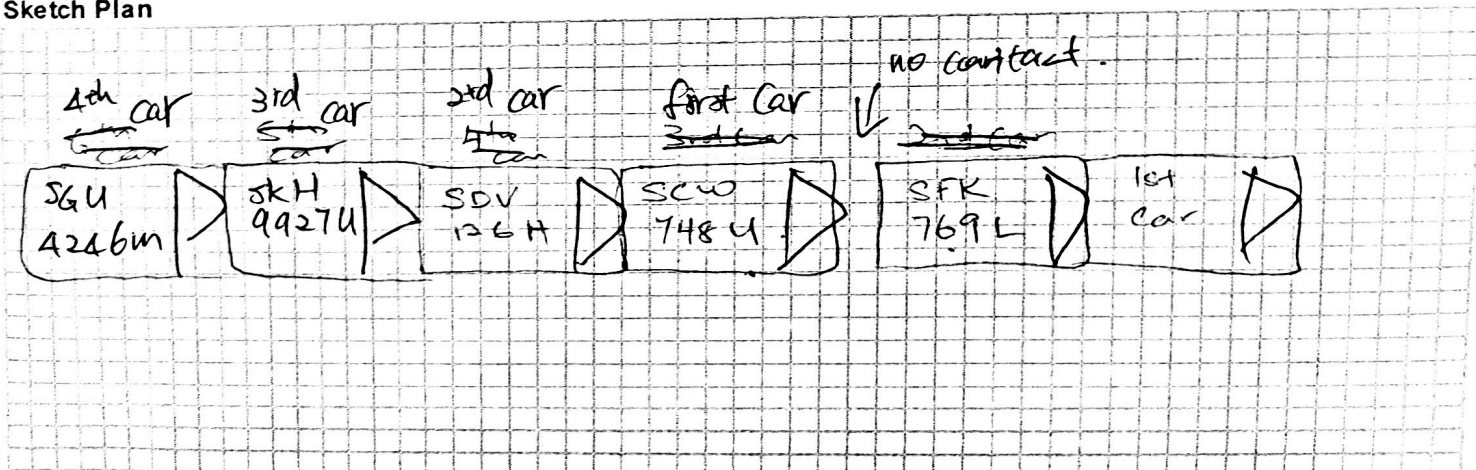

### Sketch Plan




### Circumstances of the Accident
