Brief Details.

I work as a GrabFood rider. On 13/01/2021, at around 1230hrs, I was riding my motorcycle, V1) FBR8547T. After picking up my order at Jurong Point, I rided along Jurong West Central 3 and was turning right into Jurong West St 64, at around 15km/h. That place was a T-junction. As I was turning right, suddenly I felt a very huge impact from my rear. I then realised then I was hit by a yellow ComfortDelgro taxi, V2) SHC7474J. I did not see V2 at all before the collision happened, thus I think V2 was driving at a high speed.

After my motorcycle being hit from the right, it became unbalanced and fell onto its right side afterwards. There were some dents on the left side of its registration plate. There were also several scratches on the bottom of the right side of the motorcycle, especially below my right footrest, as it was rubbed against the road surface. There were also scratches on the right side of the shell, end of one of the right handle bars and left side of the front mudguard. V2 has sustained some scratches on the lower left side of the front bumper.
