Dear CEO, AIG.

I am currently a customer of AIG, insured my car under AIG motor insurance (insurance number 1800030900 -02).

I would like to share my current experience with AIG especially how its insurance agents handled the case of a motoring incident that I was in recently. Details as follows:

- a) Incident happened on 22 Jan 2021, 8.30pm at Bukit Batok East Ave 2 Junction. My car was hit from behind and my rear and bumper was damaged.
- b) I made an immediate report the next day to AIG and my car was inspected by the AIG team

Till today, my case is not resolved.

What was most disappointing was how my case was handled. The AIG team informed me that there was no evidences of the other party car hitting my car because the pictures I send did not show the two cars in close proximity. When my car is hit from the back, there is an impact that pushes my car forward and hence a gap between the two cars will happen. So it does not make sense that AIG team expects to see a bumper to bumper picture.

Then I was also told that the other car owner claimed that no damages was done to the cars. In truth my car is damaged.

Attached are all the details I submitted and correspondences.

As a paying AIG customer, I do expect a level of service from the AIG team and also care towards your customer that was involved in an accident. Instead I did not get any assurance that my case is handled properly and thoroughly and I even was made to feel that the incident was minor and that the damages my car incurred was negligible. Is this how AIG process cases that come your way?

The insurance coverage of my car is ending end Mar 2021 and <u>I am rethinking whether I should</u> renew my car insurance with AIG.

Overall, I am disappointed and dissatisfied with how my case is being handled. And I would like to see an expeditious and thorough review of my case and for the AIG team to keep me updated, instead of me having to call them and ask on status.
