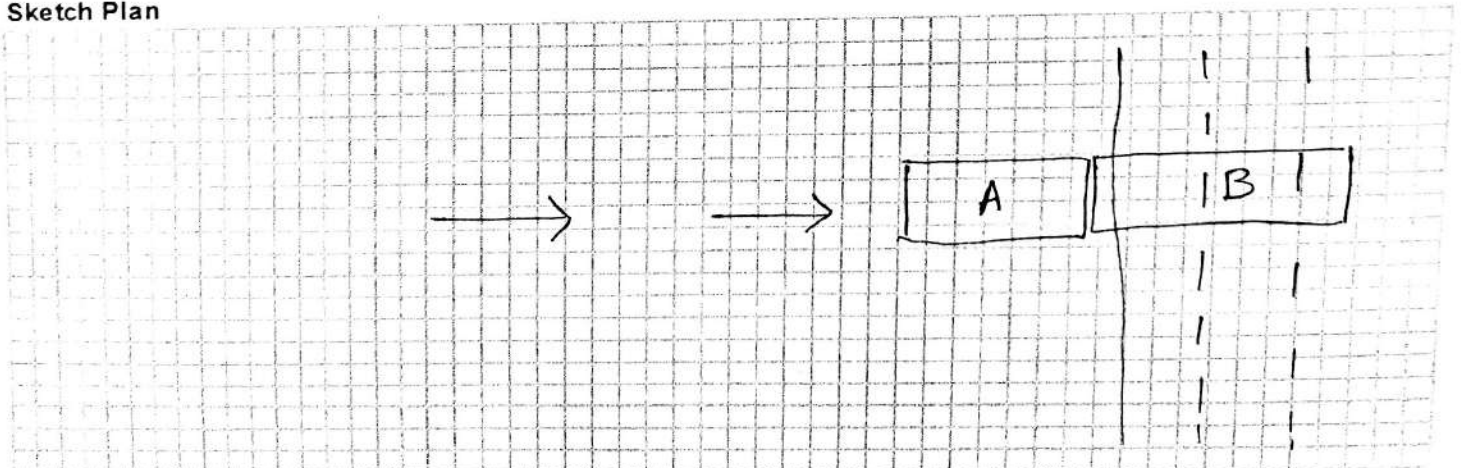

Describe Circumstances of the Accident

Driving along Sembawang road at 6.35pm on 25/1/2021, Infront of me was a grey volvo SLV 4029J. As I was approaching the junction I noticed the light turn yellow as I was approaching the 2nd arrow before the junction.

The car before me appeared to be carrying on through the junction with no indication that it was braking. Suddenly he jam broke infront of my car when his car had crossed ~~about~~ the stop line. About 5/6th of his car with ~~his~~ ~~too~~ had crossed the stop line and only his boot area was behind the line.

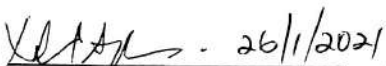
I tried to break in time and did stop before the stop line but because the rear end of his car was 1/6th still before the stop line I bumped into his back.
