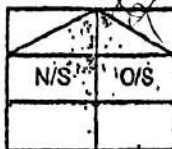

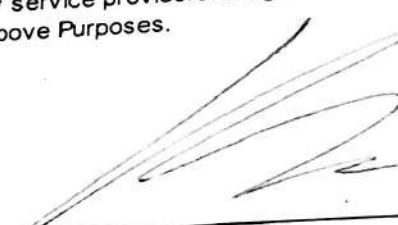
SKETCH PLAN

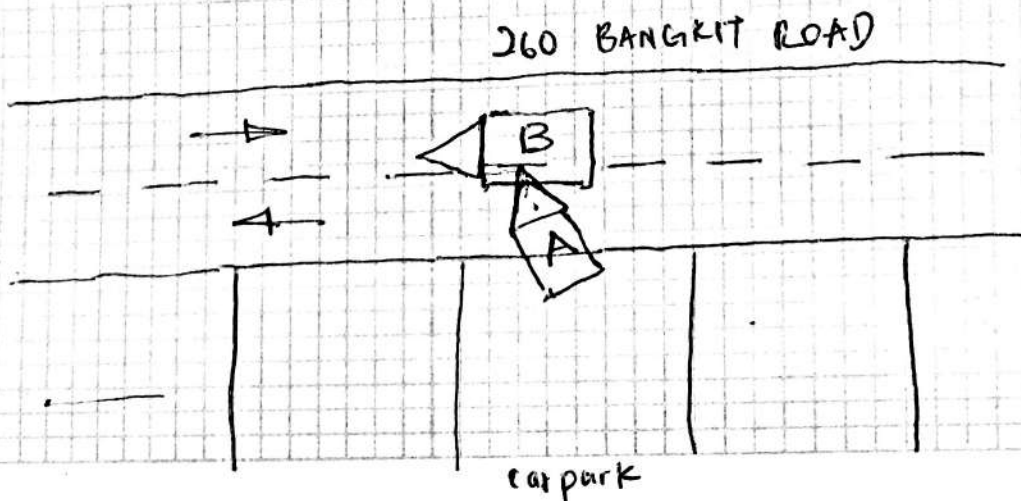
