CIRCUMSTANCES OF ACCIDENT

R2000006984 Circumstances Of Accident I was driving along Bukit Timah Road at 12.28pm on 16 JAN 2021. Traffic was slow moving. There was a heavy vehicle in front of me

moving slowly. I indicated my right signal

intention to change to the right hand lane and to continue straight ahead. I checked my right view mirror and noticed the car on my right was moving slow and not accelerating. I then continued to move to the right lane. It was then when I felt a bump to the right rear of my car. I pulled to the side and the car behind me followed. There was minimal damage to the rear right of my car. There was some superficial damage to the front left of the car (SMF2221E). I informed the driver of SMF2221E that I had indicated clearly that I intended to move to the right lane and noticed he had slowed down. That was when I decided to move to the right lane. The driver of SMF2221E mentioned another car on his right had hit his car but drove on. There was superficial damage to SMF221E right view mirror

caused by another car (no details of other car driver who drove off).
