CIRCUMSTANCES OF ACCIDENT

I was driving along Balestier road just before the bus stop outside the Singapore Indian Association. I drove on the 1st lane to go straight to Whampoa at the next bus stop as the 2nd and 3rd lane were congested. On the 2nd lane, another van (GBH7860Y) suddenly changed into my lane. I could not brake on time and collided onto the driver side of the van. My bus had some minor scratches while the van also had scratches. No one was injured. We exchanged particulars after both of us parked at the next bus stop. However, one of my passenger (Mirna, h/p : 96279540, 83 whampoa drive, #08-294) complained that her son knocked onto a pole inside the bus. She informed that her son was fine and did not need to see doctor. I also had a witness that saw that the van cut into my lane which resulted in the accident. (Witness : Imansyah Budiman, h/p : 97556327). That 's all.




