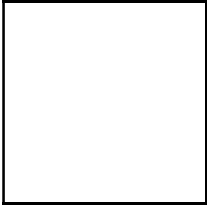

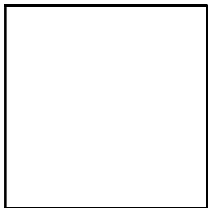

Regret to inform that we are unable to accept the offer at \$7,630 under global sum basis.

As the accident took place on 27.01.2021, our client's vehicle is a new vehicle. Therefore, we have arranged a new rental vehicle with similar capacity to assist him on his daily needs. Under NIMA rental rates benchmark, the rental rate is ranged between \$100-\$120 per day. As both our client and the rental vehicles are relatively new, we trust that \$120/day is reasonable. 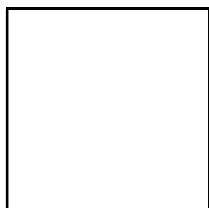
