Brief Details.

On 31 Oct at 5:50pm, was along upper paya lebar road. stop my vehicle SME 1303P To alight front passenger (my wife). Vehicle came to a stop. Wife open door, motobike FBQ 8774 J, collided into front passenger door and also my wife left leg.

Exited vehicle to check on wife & motorbiker. His bike was leaning on his leg. He told us to move the bike away to free him. I observe he has no visible injuries. We kept asking him if he was fine. He reply yes he is fine.

My wife left leg was bruised. Scalded by motobike engine. Car door slight damage. observe bike had some fluid leakage. no other major visible damages on the bike.

We moved the bike, motorbike's friend (another pizza delivery biker) escorted him to sit at the restaurant to rest. He is fine. He hobbled to the chair and sat down. Biker friend then told him to call ambulance. He then gave me his Domimoes Manager mobile. (Jannah 87743145) I called and ask her what I should do, she advised me to call the police. I called the police to inform them of the incident.

Shortly after the Ambulance came. Check up on the rider, strap his legs and brought him into ambulance and left the scene. I waited for the Traffic police to arrive to explain the incident.




