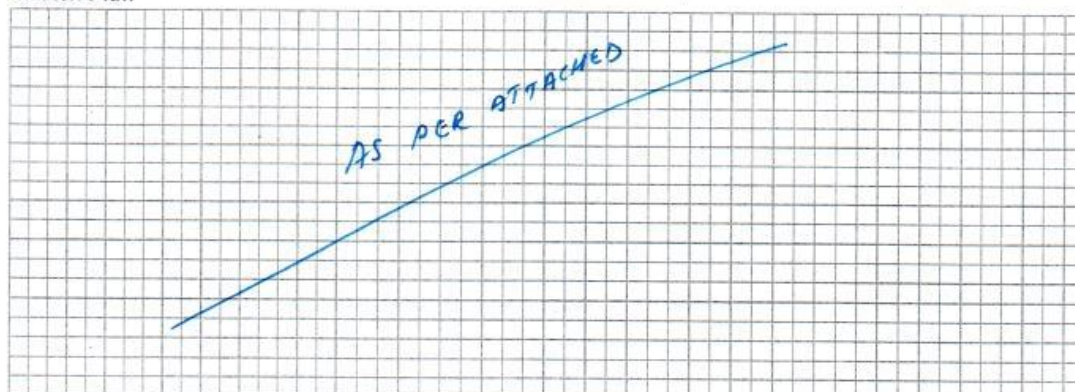

 onto my rear portion of my veh.

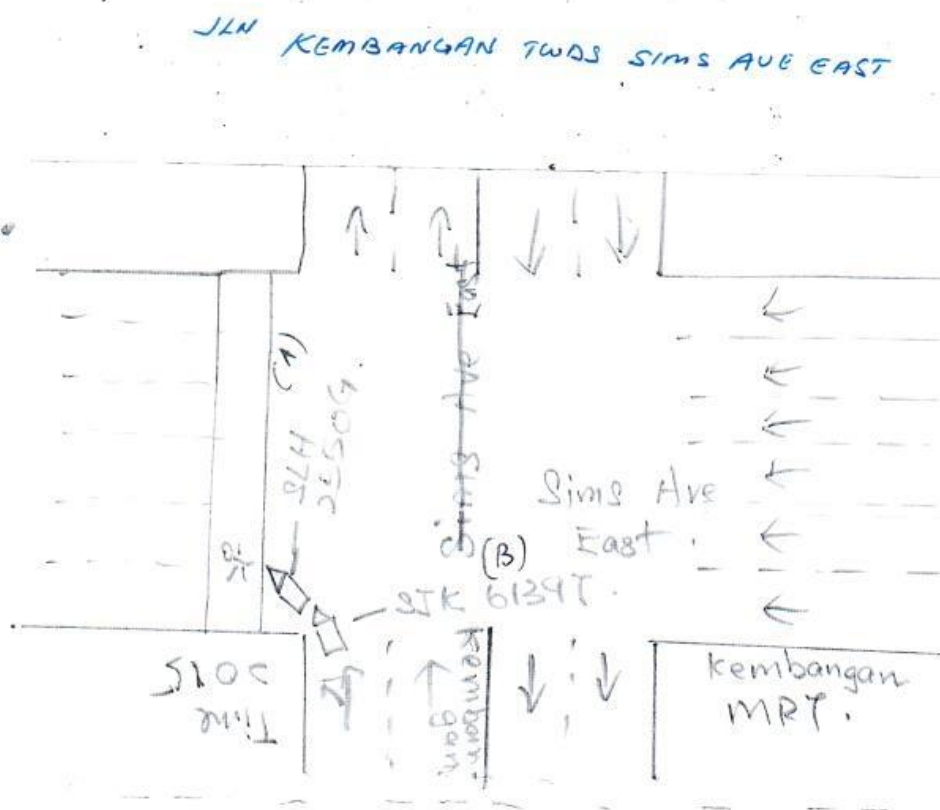
