Please note that investigation has been conducted summary of results below..

### "quote"

- Did not consumed any alcoholic drinks prior to the accident,
- Was heading to his office from home to retrieve some office documents as he ah a meeting the next day.
- Claimed that he thought he saw something approaching near his vehicle from the left side and thus, he swayed to the right. He further claimed that he was tired and might be seeing things.
- After the accident, the car was not able to move. He contacted the towing truck which arrived at the scene.
- Remained at the scene to divert traffic. Few passerby motorists stopped to assist him but did not take down their particulars.
- No police or ambulance attended to the accident.

Meanwhile, I had made a discreet checks with Traffic Police on the matter and was advised that the accident was not investigated by them. Insured driver was not investigated for any drink driving related issues. Media social checks also did not yield anything on the accident.

Based on the above information and findings, I am not able to detect any incriminating factors involved in this claim. I have no reason to prevent you from settling this accident on fair and reasonable terms. "unquote"
