We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte. Ltd. to deal with the third-party claim against your policy.

We have received a claim from SMW7659D against your insurance policy.

Based on both parties report and all the available information on hand, we are of the view that liability is not in your driver favour as your vehicle rolled backward and collided onto third party vehicle who was stationary behind your van. Therefore, we shall proceed to negotiate for an amicable settlement of the third party claim at best to avoid further litigation, which would escalate to even more cost.
