CONTINUATION OF REPORT

Brief Details.

On 23/01/2021 at about 2230hrs, I was riding motorcycle JRC6736 along Senoko Drive going towards Senoko Crescent (near lamp post 17). Suddenly, there was a blue colour taxi SHA6049X which was travelling on the opposite side traffic wanted to make a right turn. The said driver did not signal 'right' and he just turned right towards my direction. He did not check properly to make sure it is safe, before he made the right turn. His taxi then collided onto my motorcycle and I fell onto the road on my left side. The driver is Ang Hock Is, S1592949I, Blk 218 Petir Road #11-377.

The traffic police came to the scene. Ambulance also came and conveyed me to Khoo Teck Puat hospital. I then saw the doctor and my wounds were bandaged up and I was discharged from the hospital. I was given 07days of MC from 23/01/2021-29/01/2021. I suffered multiple abrasions on the left side of my body. Which are on my left shoulder, left forearm, left calf/shin area and my left toe, my left hand last 2 fingers also had abrasions and nail chipped off. I also suffered abrasions on my right leg shin area. My motorcycle was damaged badly and cannot be rode for now. It is now in my company compound at Senoko.
