We refer to the above matter.

Third party reported that he was driving straight along Victoria Street. Suddenly our insured lorry swerved left and hit onto the rear right side of his car.

Our insured driver reported that he was driving along Arab St turning left into Queens St. While he was turning left, third party tried to overtake him from the left to go straight as such collided the left part of insured lorry.

We have informed OI about third party claim and OI disagreed on third party claim. According to OI, the accident location is one way lane before the junction, our driver was making a left turn and third party tried to overtake him from the left and resulted the collision. No video footage from OI, only accident scene photos.

We have requested evidence from third party but no reply/response yet.

Based on OI scene photo, the accident location was happened along Arab Street instead of Victoria Street as per third party report. We are of the view that our insured version is more probable.

In view of this, we are intending to reject third party claim and we will review if any evidence submitted by third party.
