

CONTINUATION OF REPORT

Brief Details.

I suppose the Mercedes was waiting for vacant lot.

I was moving out of the lot when I noticed that there were not much room left by the Mercedes for me to move out. Hence I encroach slowly right out of the lot using the limited space. While doing that, I grazed a little past the car (unknown reg no.) parked beside me. As I thought it was nothing and I was in a hurry, I left without leaving my contact details. I do have a dash cam in my car but I have not yet make a check if the footage is still available.

I wish to state that I am willing to compensate the damage caused by the impact. I do not remember the other party's car plate number.
