SKETCH PLAN




Describe Circumstances of the Accident

Chronology of events leading to the accident :

1. The accident occurred in the evening inside the parking building of Parkway Parade shopping centre.
2. Teresa Cheong was the driver during the incident.
3. The road that leads up to the parking lots has 2 entry points. Our car was on the right and claimant's car was on the left.
4. The space in parkway is wide and there is ample room for 2 cars per direction and Teresa Cheong proceeded as usual.
5. When Teresa turned left to go up the ramp, the claimant's car hit our vehicle on the rear left and there was slight damage to the area.
6. The claimant accused Teresa of hitting their vehicle but we disputed their accusation, as it is impossible as we were trying to drive slow and move forward.

The claimant should have exercised softtety and caution as she (Huo Ruo Wei) has full frontal view of our car and did not apply the necessary brakes as needed.
