

Describe Circumstances of the Accident

On above date & time, I was driving my vehicle A (GBG796C) traveling along PIE towards Changi Slip road to TPE (SLE) on most right lane of a 2-lanes, road. Somewhere before exit to TPE, vehicle C (SJG3243R) ahead slowed down and stopped due to heavy traffic flow. As such, I applied brake and stopped completely behind vehicle C. Out of sudden, vehicle B (GBB4258M) came from rear and collided onto the rear portion of my vehicle. Due to the impact, my vehicle surged forward and collided onto the rear portion of vehicle C. After accident, I alighted and realised I was involved in a 3 car chain accident.
