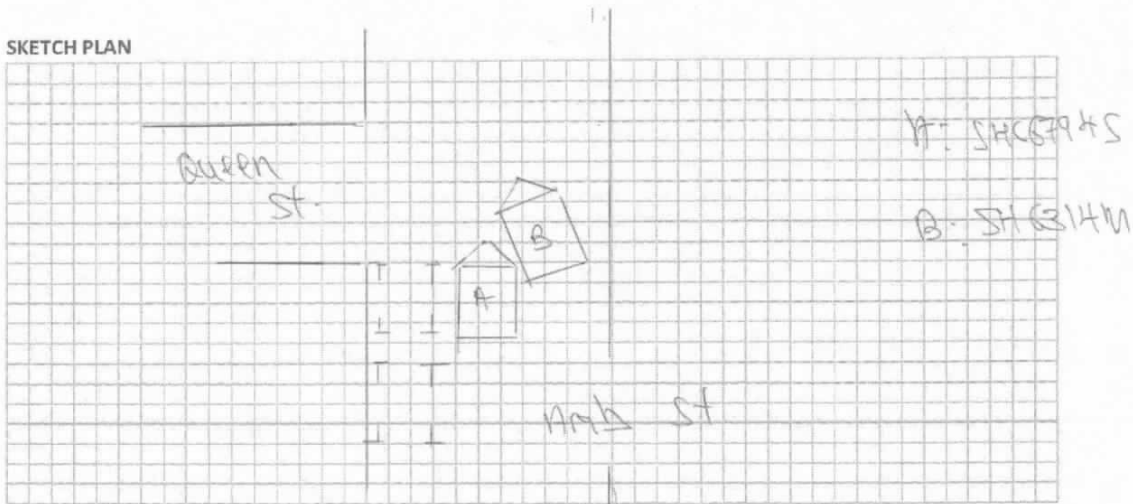

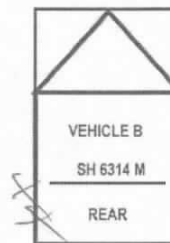
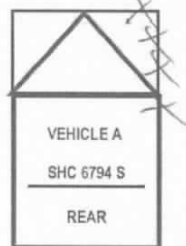
DUE TO THE IMPACT, MY TAXI DAMAGED ON THE FRONT RH PORTION
