CIRCUMSTANCES OF ACCIDENT

I WAS DRIVING ON KIM SENG ROAD ON THE MOST RIGHT LANE. I THOUGHT THIS LANE ALLOWED FOR BOTH GOING STRAIGHT AND TURNING RIGHT. AT THE JUNCTION OF KIM SENG ROAD AND HAVELOCK ROAD, I WAS HEADING STRAIGHT TO OUTRAM ROAD. THE CAR ON THE NEXT LANE (ON MY LEFT), WAS TURNING RIGHT OF THE JUNCTION. WHILE I WAS GOING STRAIGHT, I HIT THE BRAKES IN TIME. THE OTHER CAR TURNED RIGHT AND KEPT GOING. I DIDN'T FELT A BUMP SO I THOUGHT THERE WAS NO PHYSICAL CONTACT BETWEEN THE CARS. AND I ALSO DIDN'T SEE THE OTHERS CAR SLOPPING SO I PROCEEDED TO ARRIVE TO MY NEXT DESTINATION. 10 MINUTES LATER AFTER I PARKED, I CHECKED MY CAR AND REALIZED THERE WAS A SMALL SCRATCH & SMALL DENT ON MY FRONT BUMPER AND FENDER. THUS I CONTACTED THE AUDI SERVICE CENTER THIS 3AM AFTERNOON TO FILE A REPORT AND FIGURE OUT THE DUE PROCESS.

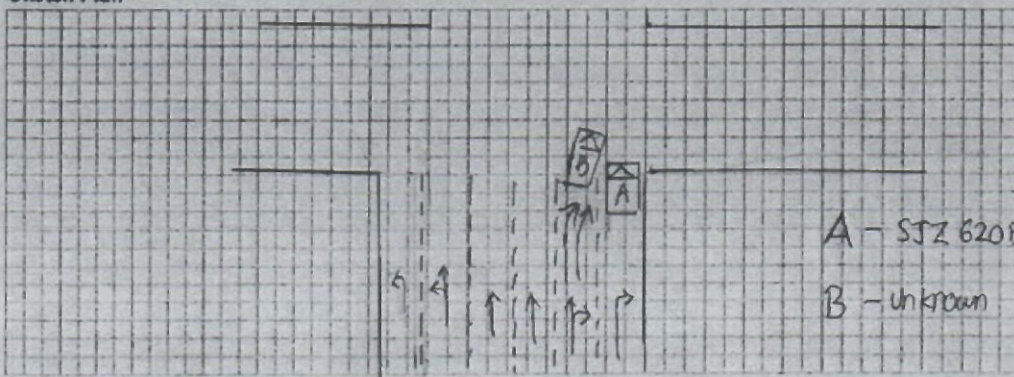

Describe Circumstances of the Accident

I was driving on Kim Seng Road, on the most right lane. I thought this lane allowed for both going straight and turning right. At the junction of Kim Seng Road and Hawlock Road, I was heading straight to Outram Road. The car on the next lane (on my left), was turning right at the junction. While I was going straight, I hit the brakes in time. The other car turned right and kept going. I didn't feel a bump so I thought there was no physical contact between the cars, and I also didn't see the other car stopping so I proceeded to drive to my next destination. 10 minutes later after I parked, I checked my car and realised there was a small scratch & small dent on my front bumper & fender. Thus I contacted the Audi service center this same afternoon to file a report and figure out the due process.
