Brief Details.

On the 31/01/2021 at about 0744hrs, I was riding my motorcycle bearing plate number VCT3242 along Tampines Street 23 towards the direction of Tampines Ave 2. At that time, the weather was clear and road surface was dry.

While riding, that was when I noticed a blue in color taxi bearing plate number SHA1007A from the opposite lane (towards Tampines Street 21), signaled its intent to enter Blk 210 Tampines Street 23 carpark. At that time, I was already in close proximity and as such, sounded my horn to the taxi to warn of the danger. However, the taxi still proceeded on to enter the carpark. I then attempted to brake my motorcycle to avoid the collision but as I was already at close proximity, I was unable to stop my motorcycle. As such, my motorcycle collided with the rear side of the taxi and I fall onto the taxi, then to my right side.

That was when a passerby, namely Fabian came and render assistance to me. Fabian informed that he had already called for police and ambulance. Fabian then assisted me to sit at the roadside while awaiting assistance. Fabian also assisted to exchange particulars with the taxi driver. Due to the accident, I felt some pain around the left upper body area and right knee area.

Another witness, S1, came up to me and informed that he had a video of the footage and sent me. I wish to state that I do not have the name of S1.

Shortly later, the ambulance arrive and give me some medical attention. Later on, the traffic police arrived and interviewed me. I was given a case number G/20210131/0092 and conveyed to CGH thereafter. I was given a 3 days of medical leave and was discharged on the same day.

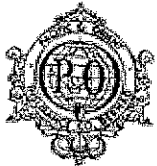
