REFER TO POLICE REPORT NO: (D/2018024/7008) ON 23/08/2018 I WAS DRIVING MY VEHICLE SKX76A ALONG AYE TOWARDS CLEMENTI DIRECTION. AT ABOUT 5.55PM, A VEHICLE BEARING EE71J SWERVE IN TO MY LANE FROM THE ROAD DIVIDER. THE VEHICLE HIT ON TO THE LEFT SIDE OF MY CAR. 


