WHITE HYUNDAI DID NOT STOP THE CAR UPON IMPACT AND CONTINUED ACCELERATING WHILE I HOLD ON TO MY BRAKES TO PREVENT THE CAR ON THE ADJACENT RIGHT OF MY VEHICLE FROM IMPACT.

AN EYEWITNESS (NAME: BELLE, HP: 90991206) WAS ALSO PARKING HER VEHICLE, 3 PARKING LOTS FROM THE SITE OF THE ACCIDENT PROVIDED HER IN CAR CAMERA FOOTAGE OF THE WHITE HYUNDAI DRIVING AND STATED THAT THE DRIVER OF THE WHITE HYUNDAI WAS DRIVING VERY FAST AFTER A LEFT TURN THROUGH THE PEDESTRIAN CROSSING PRIOR TO IMPACT WITH MY VEHICLE. THE SPEED LIMIT OF THE CARPARK IS STATED TO BE BELOW 15KMH.

GIVEN THE INITIAL ASSESSMENT BY THE INSURER'S AUTHORIZED WORKSHOP, THE EXTENT OF THE DAMAGE TO MY VEHICLE ALSO INDICATED THAT THE CAR WAS IMPACTED AT A HIGH SPEED.

GIVEN THAT MY VEHICLE WAS PARKED NEXT TO A PEDETRIAN CROSSING, THE EXTENT OF DAMAGE ON MY VEHICLE AND INDICATION OF THE HIGH SPEED DRIVING BY THE DRIVER OF THE WHITE HYUNDAI COULD HAVE SERIOUSLY INJURED AT PEDESTRIAN IN THE CARPARK IF AN ACCIDENT OCCURED.

THE BUILDING MANAGEMENT HAS BEEN CONTACTED ABOUT THE ACCIDENT AND HAS BACKED UP A COPY OF THE CCTV FOOTAGE OF THE ACCIDENT THAT CAN BE MADE AVAILABLE UPON A POLICE REPORT AND INSURER REQUEST.
