

Describe Circumstances of the Accident

On 5th Feb 2021 at 2:50hrs, I was driving my vehicle SF277675 along Pasir Ris Ave 8 towards junction of Pasir Ris Drive 1.

As I was travelling along the 2nd lane approaching the traffic junction, a motorcar (SMP 49255) coming from the 3rd lane cut into the 2nd lane which is in front of me. As that 2nd lane is meant for going straight and turning right.

However, the said car did not make a right turn but stopped at the junction and he signal left indicator light which I presumed that he was not going to turn to the right but instead going straight.

So I decided to overtake him and switched my lane over ensuring that there was no oncoming vehicles coming from my rear right. However, as I was maneuvering my car to switch lane, my car accidentally side swipe the front car which resulted damages to both vehicles.

CAR A (SF2 77675)


