





Brief Details.

On 05/02/2021 at about 1245hrs, I was leaving Bukit Panjang Government High School towards Choa Chu Kang Ave 4, I was driving my father's vehicle (Ho Chin Onn , S1234517H) bearing registration number (SKE348R). While travelling along Choa Chu Kang Ave 4 at the Junction of Choa Chu Kang Walk initially I wanted to filter to the right lane and exit towards Choa Chu Kang Way but I decided to make a u turn as I saw there was no car on the opposite side. I am unsure if there is a U-Turn sign. When I was about to turn I made a brief check on my blind spot but did not spot any car, while I was turning back towards Choa Chu Kang Ave 4 at the center of the junction a white van bearing registration number (PC2078H) collided on to my driver's side door and my rear bumper was damaged and dented. I was knocked out and conveyed to Ng Teng Fong General Hospital and I was admitted to the Emergency Department from 05/02/2021 at 1418hrs to 06/02/2021 0844hrs. I was also given 4 days of MC from 05/02/2021 to 08/02/2021 and suffered from scalp haematoma and a few cuts on my face due to the accident. Traffic Police was also at scene. I wish to informed that my vehicle was installed with dashcam and the video footage was handed over to Traffic Police. I am not sure the other party injuries and the damaged of his car. That's all.
