

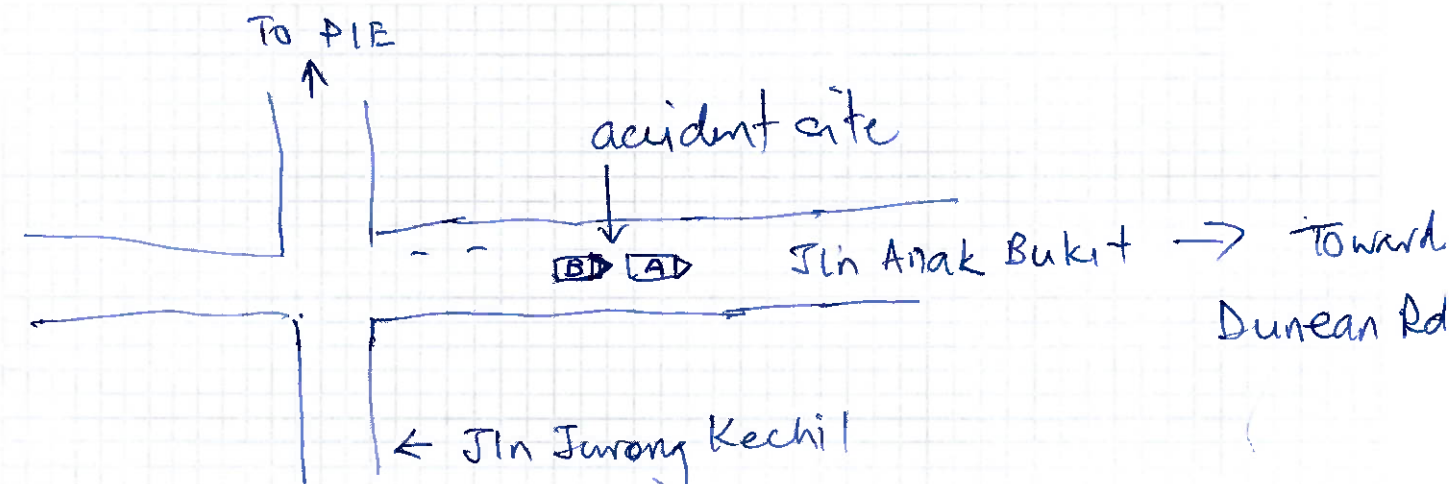

I was driving and going straight in the centre lane of 3-lane Jalan Anak Bukit towards Dunearn Road on Saturday, 6 Feb 21, at about 8:43am. The road was dry and the weather was fine. Traffic on Jalan Anak Bukit was heavy and slow moving that morning. I had stopped my car behind a light goods commercial vehicle in the slow moving traffic and a short moment later a white Audi A3 car (SLL3330Y) knocked into the rear bumper of my car (SFQ3361C). After accident review of my in-car rear camera showed that the white Audi A3 (SLL3330Y) was on the extreme left lane of Jalan Anak Bukit and was trying to filter to the extreme right lane.
