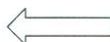


Letter of Authorisation & Indemnity




