on the 4th Feb, at 655pm, at King Albert Park Road, as I was waiting for the traffic light, my car had accidentally reversed rolled back and hit the front bumper of another car, SJY 1147D. Immediately i went out to survey the damage and saw that the number plate and bracket was bent, nothing else was damaged. I exchanged the number with the grab driver, identified only as Mr Chua and we moved on. That night, he sms to me saying he will check his car radiator if it was damage. I asked him to go to my mechanic the next day and he agreed.

The next day, 5th Feb, he contacted me and told me that he has gone to his mechanic and reported that

nothing else was damaged except the number plate and bracket. He asked for \$600 as a compensation and I said that there were 2 options: 1. go to my mechanic and i'll have the number plate & bracket repaired (my mechanic quoted me \$50) or I compensate him \$100 to settle. He then asked for \$200 and I refused as the actual repair is only \$50. He also said he did not want to involve insurance and prefer to private settle with me. I have the conversation recorded on this.

A few hours later he sent me a few pictures of other parts of the car claiming to be damaged by me and asked to have them repaired by my mechanic. I replied those were not even hit by me and he has already confirmed by his m mechanic that nothing else was damaged beside the number plate and bracket. He left me a voicemail asking for more money. I called him several times and he did not pick up.

On the 8th Feb, after he didnt return call, I called him again at 11am and asked him to return call but he did not again. At the point of filing this report, it has been more than 24hrs and he has clearly not tried to reach back to me.

I am filing this report upon advice from my lawyer, as he has sought to extort from me, sending me pictures of parts that I did not hit and he did not return my calls to clarify. Everything I said above is accurate and filing this report to protect the truth and coming forth as a clear indication of a good faith from my part.
