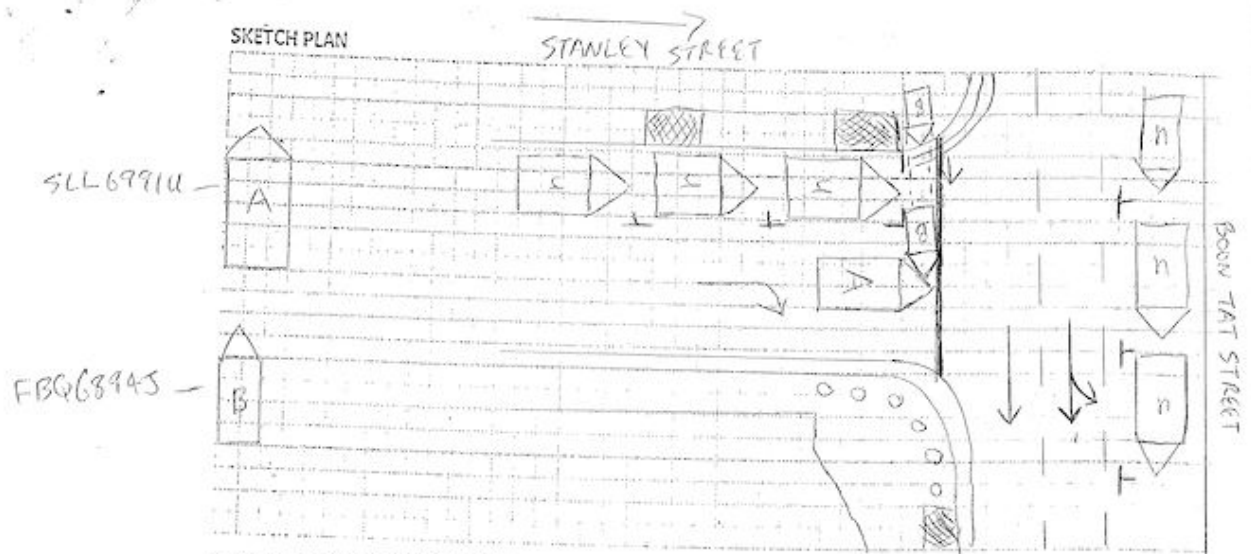

**Brief Details.**

I had previously lodged a traffic accident report T/20210208/2063.

On 08/02/2021 at about 1020hrs, I was driving my rental car (SLL6991U) slowly along Stanley Street. As I was slowing down to stop and check for oncoming vehicles before making a right turn into Boon Tat Street. A motorcycle (FBQ6894J) suddenly dashed out from the pedestrian sidewalk of SICCI Building with the rider looking behind him instead of in front of him and forcefully hit onto the left front side of my rental car. The rider then fell onto the ground and got up again.

I stepped out of my car and asked him why he was so careless and hit my car. The rider then moved his motorcycle slightly in front of my car. We exchanged particulars and he did not say whether he required any medical assistance or any conveyance to the hospital. We both then left.

No Traffic Police or ambulance came to the scene.

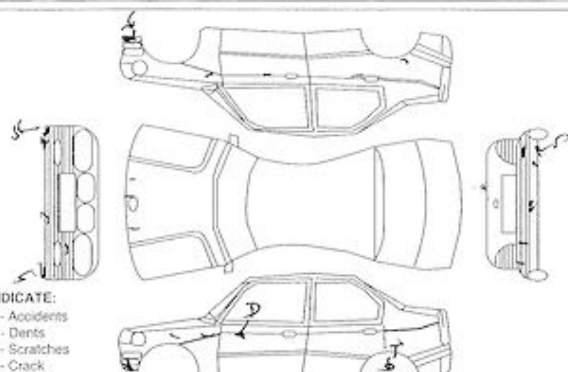
